has called for implementation of the 1997 Leahy Amendment, under which US military assistance cannot be provided to foreign armed forces suspected of committing, supporting or tolerating human rights violation.

Pakistani forces are carrying out gross violation of human rights in Balochistan, he alleged.

At least 36 people were killed and 12 others missing in floods and landslides triggered by incessant rainfall in several districts across Nepal, officials said on Saturday.

According to the Ministry of Home Affairs, seven persons were killed in Sunsari district in southern Nepal.

Four persons were killed in Sindhuli, four each in Jhapa and Sindhuli districts, three each in Banke, Morang and Panchthar districts and the rest others in different districts.

Hundreds of families have been displaced in the floods and landslides across the country.

Meanwhile, Nepal Cabinet held an emergency meeting during which Prime Minister Sher Bahadur Deuba ordered the local district administrations to intensify the rescue and release activities.

Nepalese Home Minister Janardan Sharma said that all the security agencies will be mobilised in an integrated manner for carrying out the rescue operations.

Jhapa, Morang, Sunsari, Saptthari, Siraha, Sarlahi, Rautahat, Banke, Bardiya and Dang districts were the worst affected by flood.

against Venezuela in response to its president Nicolas Maduro's power grab, describing the situation in the country as a "very dangerous mess".

Protests rocked the streets of Caracas and other Venezuelan cities after a July 30 vote that allowed Maduro to replace the opposition-dominated National Assembly with a new 545-member Constituent Assembly filled with his supporters.

The Trump administration has called Maduro a "dictator" and issued sanctions against him and more than two dozen other former and current officials, accusing Maduro's government of violating human rights and

Venezuela. And by the way, I'm not going to rule out a military option. We have many options for Venezuela," Trump said after a meeting with his Secretary of State Rex Tillerson, Ambassador to the UN Nikki Haley and National Security Advisor HR McMaster.

"This (Venezuela) is our neighbour. You know, we're all over the world. And we have troops all over the world in places that are very, very far away. Venezuela is not very far away. And the people are suffering. And they're dying. We have many options for Venezuela, including a possible military option if necessary," Trump said. **PTI**

## Powerful blast kills 12 people in Pak

**Karachi:** At least 12 people were killed and over 20 others injured on Saturday in a high intensity blast in Pakistan's Quetta city.

The blast took place in a parking lot near Pishin bus stop which is in a high security area. Baluchistan's Home Minister Mir Sarfaraz Bugti said the bomb was apparently kept in a vehicle parked near the bus stop. "Investigations are continuing but I can confirm it was a big explosion and there are around two dozen injured who are being shifted to nearby hospitals," Bugti said. Twelve dead bodies were brought to the hospital and they were all badly charred and burnt, Duniya channel reported.

The blast was so loud that it was heard in far off areas and caused a huge fire in which some vehicles and auto rickshaws were also damaged. **PTI**
